




What is the Summer Rain Barrel Program?

The Summer Rain Barrel Program is a collaborative that provides City of Cleveland residents with rain barrels free of charge. The effort helps reduce stormwater runoff, helps residents save money and engages Cleveland youth. The Mayor's Office of Sustainability partners with Youth Opportunities Unlimited (YOU), the Mayor's Youth Summer Employment Program (YSEP), local Community Development Corporations (CDCs), the Cleveland Division of Water (CWD), and the Northeast Ohio Regional Sewer District to employ City of Cleveland high school students to assemble and distribute rain barrels to city residents.

City of Cleveland Summer Rain Barrel Program

Who is eligible to participate?

The Summer Rain Barrel Program is open to all home owners in the City of Cleveland. Residents may be required to show proof of ownership in order to participate in the program. Residents also must: Be able to provide proof of home ownership, complete the required paperwork, have a 2"x3" rectangular downspout on their home or garage that is not visible from the street and drains to a sewer, install the free downspout diverter by the time the rain barrel is delivered. The City of Cleveland is not responsible for diverter installation.



How do I sign up for the Rain Barrel Program?

Registration for the Summer Rain Barrel Program is administered by local Community Development Corporations (CDCs). Cleveland Water Pollution Control (WPC) promotes the use of rain barrels for stormwater management, but WPC does not administer the program or distribute rain barrels.
